# ONE DAY EDUCATION PROGRAM GORKHA DISTRICT CHAPTER

#### **District Profile**

Gorkha District, a part of Province No. 4, is one of the seventy-seven districts of Nepal. The district, with Pokharithok (Gorkha), later known as Prithivi Narayan Nagarpalika as its district headquarters; covers an area of 3,610 km² and has a population (2001) of 288,134. Four major rivers run within and along it - the Chepe, Daraudi, Marsyangdi, and Budhi Gandaki.

#### **Program**

On July 21, 2017, Gorkha District Chapter conducted One Day Educational Program at Gorkha. The duration of training program was 7 hours (9am to 4pm). The training program was conducted by Human Rights Trainers, member and Program Officers.

One Day Human Rights training Program has a primary objective of enabling Human Rights Defenders to become aware of how laws and social norms shape their lives both on the national levels, learn their rights and the laws as well as develop a critical awareness about them; acquire the skills to exercise their rights and be empowered to catalyze social change. 60 participants from different background attended the program with an aim to have a better understanding of the Concept Fundamental Rights, International Laws and Treaties, Gentlemen's Agreement, Civil Rights, Good Governance, Federalism, Crisis Management and Sustainable Development Goals.

Mr. Rabin Basnyat opened the program by requesting the Chief guests to inaugurate the Educational Program. He then requested the Chief Guest and all the distinguished guests to briefly introduce themselves and share their views on the Human Rights matter. Advocate Indra Prasad Aryal, President-HURON, Prof. Retd. Major General Nirendra Aryal and Mr. Rabin Basnyat highlighted on the current scenario of Human Rights, the international Human Rights convention and stressed on the importance of Human Rights educational program.

After the inaugural ceremony, the training was held. The training team consisted of Dr. Chiranjivi Bhattarai CCM, HURON and Mr. Indra Prasad Aryal, President HURON. The overall development goal of the one day educational training program was to train and educate members about Human Rights specifically our training agendas.

THERE WERE TOTAL 51 PARTICIPANTS WHERE HURON MEMBERS, MEDIA PERSONNEL, SECURITY PERSONNEL (NEPAL POLICE AND ARMED POLICE FORCE), STUDENTS, TEACHERS ETC. WERE ATTENDED. OUT OF 51 PARTICIPANTS 8 WERE FEMALE AND 43 WERE MALE.
